WHAT IS THIS PRODUCT?

Type

This product – **IMPACTUS PRIVATE EQUITY FUND II CLASS A INVESTMENT SHARES**, is a distributing class of investment shares issued with respect to IMPACTUS PRIVATE EQUITY FUND, an open-ended investment compartment (the “Investment Compartment”) of **IMPACTUS RAIF V.C.I.C. LTD** the “Company”). The Company incorporated under the Companies Law, Cap. 113 on 23/05/2019, with registration number HE398075, and operates as a Registered Alternative Investment Fund (the “RAIF”) in the form of a variable capital investment company in accordance with the Alternative Investment Funds Law 124(I)/2018, as amended from time to time (the “AIF Law”). The Company is actively managed by **ARGUS MANAGEMENT LTD** (the “Fund Manager or PRIIP Manufacturer”), a private company limited by shares which is authorised by the Cyprus Securities and Exchange Commission to operate as an Alternative Investment Fund Manager with licence number AIFM44 in accordance with the Alternative Investment Fund Managers Law 56(I)/2013, as amended from time to time. The Depositary of the Company is **MEGA EQUITY SECURITIES & FINANCIAL SERVICES PUBLIC LTD**.

IMPACTUS PRIVATE EQUITY FUND II Class A Investment Shares are issued with respect to the Investment Compartment and carry non-voting rights, in accordance with the Company’s prospectus. None of the shares issued by the Company, including IMPACTUS PRIVATE EQUITY FUND II Class A Investment Shares are listed on any regulated exchange market or multilateral facility. The Fund Manager has discretion over the investments of the Investment Compartment, subject to the provisions of the Company’s prospectus and the offering supplement of the Investment Compartment. The assets and liabilities of each Investment Compartment of the Company are segregated as per article 9 of the AIF Law. Even though the AIF Law refers to segregation between investment compartments, the AIF Law has yet to be affirmed by judicial authorities through court proceedings. As such, no definitive assurance can be provided regarding the enforceability of investment compartment segregation in case of liquidation of any investment compartment, or distribution of profits with respect to each investment compartment or in other circumstances. Investors currently do not have the right to exchange any of their IMPACTUS PRIVATE EQUITY FUND II Class A Shares into investment shares of another investment compartment of the Company. Any dividend relating to IMPACTUS PRIVATE EQUITY FUND II Class A Investment Shares is to be distributed at the discretion of the Board of Directors after proposal by the Fund Manager.

Term

This product has no fixed maturity date, however, the Investment Compartment may be liquidated upon a unanimous written resolution of the board of directors of the Company, in accordance with the AIF Law and the provisions of the Articles of the Company.

Objectives

The objective of the Investment Compartment is to maximize total investment return, primarily through recurring income generation and secondarily through capital appreciation derived from private equity and venture capital investments across a range of industries and sectors. To achieve this, the Investment Compartment intends to allocate 50%-100% of its net subscribed capital to venture capital, while maintaining the flexibility to invest 0-50% in private equity, 0-40% in real estate and infrastructure projects (renewable energy), 0-30% in other compartments of the Company, and up to 10% in ancillary cash holdings. Investments are selected using criteria focusing on project owner’s record, credibility & integrity, strong management team, positive sector outlooks, and preferably committed revenue agreements. The Investment Compartment targets projects through professional due diligence, geographically focused in Cyprus, and have potential of yielding high returns and will be mainly exposed to other alternative investments such as investments in venture capital (technology startups, early stage and emerging companies with strong potential for growth). Its core strategy involves direct investments or structuring investments through SPVs using equity, debt, quasi-equity or hybrid instruments. Where market conditions temporarily prevent full deployment of capital, the Investment Compartment


may allocate capital on an interim basis to highly liquid European money market instruments and cash equivalents to preserve capital and maintain liquidity. The Investment Compartment will not employ any leverage. The Fund Manager may change the Investment Policy of the Investment Compartment. Any changes in the Investment Policy of any Investment Compartment require the prior approval of CySEC.

Intended Retail Investor

Apart from professional investors (as defined in the Second Appendix of the Investment Services and Activities and Regulated Markets Law 87(I)/2017 as amended from time to time), this product is also suitable for retail investors who: (i) qualify as well-informed investors (as defined in the AIF Law); (ii) have a medium to high risk appetite; and (iii) are seeking returns over the medium to long term horizon. The investor's objective for this investment should be aligned with the objective of the product as outlined above and in the Investment Compartment's offering supplement.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Summary Risk Indicator ("SRI")



This product is classified as 6 out of 7 which is the second-highest class. This classification is based on the PRIIP Methodology for Market Risk Measure (MRM). This rates the potential losses from future performance at a very high level and poor market conditions are very likely to impact the capacity to pay you. Please note that the product's classification is not constant and may change over time. Other risks materially relevant to the product that are not included in the SRI include liquidity risk, operational risk, environmental risks etc.

This SRI assumes you keep the product for 5 years. The actual risk can vary significantly if you cash earlier, and you may get back less. WHAT HAPPENS IF THE PRIIP IS UNABLE TO PAY OUT?

In the event of default of the Investment Compartment, the investors are expected to face a financial loss. The investors in the Investment Compartment are not protected by any investor compensation or guarantee scheme.

WHAT ARE THE COSTS?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs consider, one-off, recurring and incidental costs. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Investment Shareholders are bound to hold the IMPACTUS PRIVATE EQUITY FUND II Class A Investment Shares for at least three (3) years. The External Manager may opt to reduce or extend the minimum holding period by up to two additional one-year increments. Redemption requests before the expiration of the minimum holding period may be considered on an exemption basis by the Directors of the Company, subject to confirmation by the Fund Manager. If approved, such redemptions will be subject to a 2% redemption fee applied to the Gross Redemption Price per Investment Share. The Fund Manager is entitled to limit the total amount which may be redeemed at a particular redemption up to 20% of the NAV. The limitation is applied pro rata.
